APPROVAL CRITERIA

Requests for a non-preferred agent for dementia or Alzheimer's Disease may be approved if the following criteria are met:

- I. Individual has had a trial (medication samples/coupons/discount cards are excluded from consideration as a trial) and inadequate response or intolerance to one preferred agent; **OR**

Preferred agents: donepezil 5mg, 10mg, galantamine/ER, memantine, rivastigmine tablets

- II. The preferred agent is not FDA-approved for the prescribed indication; **OR**
- III. The preferred agent is not acceptable due to contraindications or concomitant clinical situations, such as but not limited to the following:
 - a. Known hypersensitivity (such as, but not limited to: application site reactions with rivastigmine transdermal patch suggestive of allergic contact dermatitis);
 - b. Pregnancy category[†].

[†] Exelon and Namenda/XR are pregnancy category B; Aricept, Namzaric, and Razadyne are category C).
